*Fourteen Cars Derailed Near Ladora When Rail breaks; Iowa City Roadmaster Is Hurt Clearing Wreck (Iowa City News)*

Train service through here on the Rock Island lines was interrupted for the second time within a week by a freight wreck west of her when an eastbound train struck a broken rail near Ladora, first station west of Marengo, at 2 o'clock this morning and put 14 cars in the ditch.

John B. Pugh, Iowa City roadmaster, who went to the scene of the wreck to aid in clearing the debris, received a broken leg when struck by a rail, it was learned here late this morning.

### *Delays Mail Service*

Ten head of cattle were killed in the smashup, 500 feet of track was torn up, and wheat, lumber, flour and hides were scattered along the right of way. A carload of horses escaped injury. Papers and mail from the east, usually reaching here early in the morning, did not arrive until almost noon due to rerouting of fast trains and movements of wreckers to clear the main line west.

### *Detour Fast Trains*

Fast passenger trains from Chicago to the Pacific coast were detoured through Cedar Rapids and Iowa Falls, it was said today. No trains from the west reached here this morning it being necessary, as after the freight wreck at Newton last week, to detour trains from Des Moines and the west on a branch line by way of Alerton, in Wayne county. The first train from the west was expected to arrive here this afternoon.

OTTUMWA, April 20--(AP)--

Two Minneapolis-Kansas City trains on the Rock Island passed through here during the night, rerouted through Ottumwa because of a burning bridge just south of Charlton[Chariton?]. The Southwest limited came through about 7:45 o'clock this morning, stopping for breakfast at the union depot. The trains were delayed about seven hours.

Cause of the bridge fire could not be learned here, though railroad officers said that all available workers had been sent to the bridge last night.

### **Youngsters Aid in Flood Relief: 10 Local Children Give Play, Net \$14.51 for Red Cross Fund**

Ten Iowa children Monday night set up a stage in a garage, donned makeshift costumes, and gave a benefit play which earned \$14.51 for the Red Cross flood disaster relief fund. The children, aided by Mrs. Emil G. Trott, 630 North Van Buren street, decided to do their part in helping flood victims in Kansas and Missouri by raising money for the Red Cross. They posted notices on trees advertising the play, "Sleeping Beauty," and made all their own costumes. They used the Trott garage as a stage, closing the doors between scenes. About 40 parents, neighbors and friends were in the audience, sitting on chairs in the Trott driveway. Parents of the young performers provided refreshments. The children took a collection for the Red Cross donation.

The children who took part were Margaret, Carolyn and Emil Trott, children of Atty, and Mrs. Emil G. #### ***Tax Allocation Financing Eyed For Downtown Renewal Project***

An unusual method of financing the city's share of the downtown urban renewal project - by paying the debt on public improvements out of taxes produced by the renewal area itself -- is being considered by city officials.

City Finance Director Joseph B. Pugh Jr. said that under the tax allocation financing method being discussed by the city administration, the full tax yield of property in the renewal area would be used to retire bonds issued to pay for public improvements in the area.
