Phew Family All RC

First Phew's were in **Shrule Parish, County Mayo**: Patrick Phew died 1830 age 78 (DOB approx 1752) wife Bridget Conner died 1827 age 70 (DOB approx 1757), both buried in Moyne Cemetery.

From there two families appear, in **Shrule** and in **Ballyfruit**. Possibly the same family.

According to the message board, "Rosdaff is a section in Moyne, Civil Parish of Shrule and sometimes listed as the Civil Parish of Galway. Moyne is on the border of Co.'s Galway and Mayo. Rosdaff is near Headford, Co. Galway but on the Mayo side of the Black River".

Ballyfruit is closer to Galway, but all areas are close to each other.

So we find Phews in both Mayo and Galway records.

John Phew

1853 Evaluation Books/Ballyfruit, house and office No 1. (2 Marg Fahey, 3 Andrew Moran, 4 Thomas Kineary)

1857 Griffiths/Ballyfruit- same area as is on the census above, same people, but also has John Phew and partners as number 5. **Renting from Arthur Guinness. Who were the "partners"**.

1868 Landed Estate Court Rentals- Ballyfruit, situate in the Barony of Clare, and County of Galway

Lot 6 James Phew "Lease from 1 May 1850 for 7 years or pending cause of Squire vs. Blake"

78 acres, 3 roods and 38 perches. Same people as are in the 1853 evaluation books and Griffiths, except it was with **James Phew**. **Did John have a son James or was this an error?**

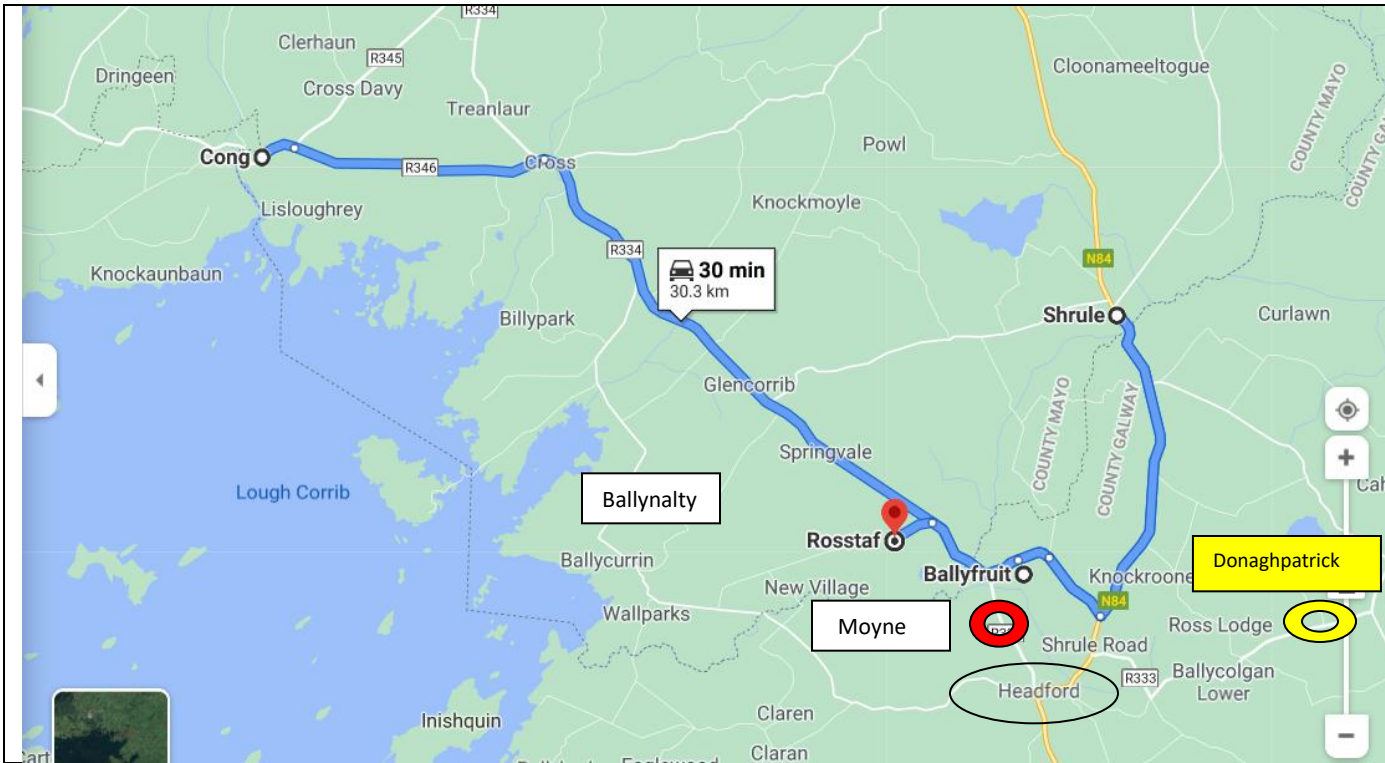

According to land records, Ballyfruit is 1 mile of Headford, 3 miles from Shrule and 16 miles from Galway.

1868 Landed Estate Court Rentals

The Encumbered Estates Court was established in 1849. In 1852, it was replaced by the Landed Estates Courts, which was itself superseded in 1877 by the Land Judges Court, part of the Chancery Division of the High Court. Although there were some differences in the powers of these courts, their principal function remained the same, to sell off insolvent estates.

Townland of Moyne, Situate in the Barony of Kilmaine and County of Mayo

Lot 1 James Phew had a lease of 31 years in **Shrule**, from Charles Blake Jr, which was held by Burke in Griffiths. **1826** "Yr to Yr tenancy, holds lease from **Charles Blake Jr**, whose father demised the lands of Shadruff to **James Phew** for term of 31 years or for the lives of **Pat Phew** and **Wm Phew**, sons. "The lives are still in being." 32 acres and 4 perches

Lot 2 Owner **William Joseph Burke** James has a total of 10 acres, 5 roods and 40 perches-yr to yr rent

Lot 3 Owner **William Joseph Burke** James has a total of 29 acres, 4 roods and 29 perches-yr to yr rent

Lot 4 Owner **William Joseph Burke** James has a total of 28 acres, 1 roods and 15 perches-yr to yr rent
Patrick has a total of 9 acres, 3 roods and 37 perches and owns an addition 13 acres and 6 perches with several other people

Lot 5 James has a total of 13 acres, 2 roods and 18 perches and Pat Phew shares with others 4 acres, 4 roods and 23 perches. Pat has yr to yr rent, but James "claims a lease of the house and 2 acres under the promise of the former owner"

Lot 6 Owner **William Joseph Burke** Pat Phew 2 acres, 3 roods and 30 perches

The **Blakes of Moyne**, parish of Shrule, County Mayo, were descended from the Blakes of Ardfry, county Galway. Under the Acts of Settlement they were granted the lands of Ballyglass, including Coolcon Castle, now situated in the parish of Kilcommon, barony of Kilmaine and lands in the barony of Dunmore, county Galway, amounting to more than 3,000 acres. At first they held Moyne on lease from the Earls of Clanricarde and in 1711 purchased the fee simple. In 1691 they bought the lands of Ballintober, barony of Carra, from the Blakes of Ardfry. The Ballintober lands were sold to the Moores of Moorehall in 1793. The rest of the Blake estate in counties Galway and Mayo was advertised for sale in the Encumbered Estates' Court in 1852. At the time of Griffith's Valuation Moyne was in the possession of Paul Ward and **Joseph Burke** and Edward S. Power had bought part of the Blake estate in the parish of Kilcommon. Charles Ormsby Blake de Burgh in a letter to George Ormsby of the Ballinamore family refers to the destruction of his family papers in a fire while in storage in London (17 May 1900)

Family of James Phew - Shrule- No birth records naming James as father, with exception of Michael-only land records and wills. We know from the land records as of **1826** James had sons **Patrick** and **William** (and from death record newspaper articles it looks like **Michael** had a father James and apparently a brother named **James Jr.** The will of **Thomas** names **Patrick, Henry** and **Bridget** Flynn as siblings and **Andrew** as nephew, making **John (husband of Mary Walsh)** his brother. Rev **Michael** and Rev **Andrew** were brothers, both from Rossdaff. **Andrew** named his brother **Thomas** as beneficiary. A newspaper article named **Martin** as brother to **Michael**.

Rev Michael Phew 1811-1866- see separate articles from newspapers, etc. He was very active trying to get support for people during the Famine. He served as priest from 1849-1864 that we know of.

Per will his father James the farmer is his only next of kin but later his brother Martin was named. According to the newspaper articles he left very little of his estate to his father and a large sum to several monasteries and convents and that was taken to court in 1867. **Ancestry Deegoogan said Michael's father's name is Jack-however, the father is clearly named James.**

Rev Andrew Phew dob unknown-abt 1812?. Not mentioned in land records, so I assume it is before William is born.

Rev Martin Phew- dob unknown-abt 1813? Not mentioned in land records, so I assume it is before William is born.

Patrick 1814-married Nellie Walsh in 1857, in **Donaghpatrick, Galway**. He died in 1897, address **Rossdaff, District of Cong, Union of Ballinrobe, County Mayo**.

Rev William Phew-dob abt 1816-after 1868. Wm is mentioned in the Landed Estate Records for James, unsure if it is the one who is the priest in Galway- per land records he was alive in 1826 and 1868. Not mentioned in other land records with James-only Patrick. Wm was ordained in 1847. He wrote a letter to the Freeman's Journal reporting the condition of people during the Famine in 1847. He is not found in records after 1859, but assuming he is still alive in 1868. No birth or death records found.

Thomas 1818, bachelor died 1890- his will clearly puts him in this family.

John 1820-Married Mary Walsh in 1855 **Castlegar, Galway**, near Galway City.

James 1822 bachelor farmer d 1878 in **Rosdaff**, left personal estate to brother Henry.

Bridget **dob app** 1826 m Thomas Sullivan in **Shrulle Parish** 1846-possibly married a Flynn later.

Henry- no dob or death, app 1830-after 1890-he is a sponsor in 1858 lived in **Rosdaff** 1874-1877 died after 1890, with James and Patrick on Petty Sessions, executor for brother Thomas and James.

Brothers John and Patrick both married in Galway, possibly married sisters?

Family of Patrick Phew (1814-1897) and Nellie (Ellen/Elenor (1827-1901) Walsh, farmer, address **Rostaff. Witnesses: John Flynn and Mary Tallon (Fallon?).**

Bridget 1858 address **Rossdiff**, bap Shrulle Parish, m Patrick Biggens 1880 Shrulle Parish, both from **Rosstaff**

Annie 1859 address **Rossdaff**, bap Shrulle Parish. There is an Annie, single, died 1934-housekeeper- address **Rossdaff**, District of Cong, Union of Ballinrobe, County Mayo. **John Hogan** present at death, probably the same one.

William 1863 address **Rossdaff**, bap Shrulle Parish. There is a William who married Catherine Reilly and their daughter Marcella was born 1882 address **Rossdaff**, bap Shrulle Parish.

James 1863-1865 based on census records and school records-he was also present at father's death. Death record 1941, bachelor farmer, address **Rossdaff**, District of Cong, Union of Ballinrobe, County Mayo. James Concannon present at death.

Honoria 1867, single, died 1949-farmer. Address **Rossdaff**, District of Cong, Union of Ballinrobe, County Mayo. **Nellie Hogan** present at death. James is living with his mother Nellie in 1901 and with sisters Annie and Nora in 1911.

John Phew and Mary Walsh-married in **Castlegar, County Galway** 1855. Address **2 Ditch**. John died 1877 leaving everything to Mary, widow. Address **Ballyfruit, Galway**. All of their children were born in **Donaghpatrick, Galway**.

Anne 1856 -There is an Anne Phew who died in 1877-age 20- a farmer's daughter, address **Ballyfruit, Galway**. Micheal Phew present-could be brother or uncle.

Catherine 1857 possibly married a Fallon, buried in San Mateo County, California 1917. Baptism sponsor is Bridget **Fallon**.

*James J Phew/Pugh 1859 m Mary Williams in California in 1889. Immigrated in 1880. Died in 1925.

*Michael Phew/Pugh 1861-married Anne Gilroy in California 1891-naturalized in 1888, died in 1904

Martin 1864-1878-address **Ballyfruit**, registration district Tuam

*Nora/Honora 1866 and Andrew-twins. Nora married a Sullivan and lived in California. She died in 1940.

Andrew Phew 1866 living with his mother Mary in Moyne, Shrule 1901 Mayo Census, lives in house 2. James Phew (son of Patrick), mother Nellie and sister Annie is on the same census in house 8 (*see Mayo Phew Time Line*) giving more proof that Galway and Mayo Phews are related. Andrew later married Mary Agnes Ward at Chapel of Shrule in 1905, they had a son Joseph in 1910 died age 14- they are all buried in the **Moyne Cemetery in County Mayo**.

James, Michael, Catherine and Honor immigrated to California .

Headstone in California with the name of James Pugh 1925, Harry **Biggens** 1932, Kate **Fallon** 1917, Anne **Flynn** and Honora (Nora) **Sullivan**. Thomas (uncle) also named Kate **Fallon** and Anne **Flynn** in his will. His sister Bridget was married to a **Flynn**, Anne is possibly her daughter. His niece Bridget married Patrick **Biggens**, his sister Bridget married a **Flynn**, probably married to a **Sullivan** first. There were several witnesses/sponsors with the name of **Fallon**. Most likely all related but difficult to know how.

Fr. Michael and Fr. Andrew Phew Both born in the townland of **Rostaff, near Moyne**, they belonged to a wealthy and respected family which gave it's last three sons as priests to the diocese. Fr. Michael was appointed to replace Fr. James Geraghty as P.P. in 1847. For many years he had to say mass every Sunday both in Shrule and in Kilroe until 1857 when his brother Fr. Andrew was appointed as his curate. In 1864 Fr. Michael retired and Fr. Andrew was transferred as soon as a new P.P. was appointed. Fr. Michael died in his home place on the 7th Mar 1866.

The Reverend Phew wrote to the commissioners January 8, 1848 that the poor starving people of Shrule were "almost neglected by the vice-Gardians of this Union. About three or four hundred of the most destitute families of this division have crawled to Ballinrobe (a distance of 10 or 12 miles) every Friday for the last month, seeking admission to the workhouse or outdoor relief." He continued: "and yet though they remained each day until night, standing in wet and cold at the workhouse door, craving for admission, they have got no relief and I do now most solemnly assure you that, but for a few shillings which I used to distribute to buy bread to enable their poor families to return home very many of them would have died by the road-side whilst returning from Ballinrobe. Six poor creatures who have been dragged to Ballinrobe in this manner, have died in this electoral division this week, and I am greatly afraid that treble that number will meet the same awful death before this day week."

Family of James Pugh (son of John and Mary Walsh) and Maria Williams, in San Mateo, California

James J 1859-1925 married to Mary Williams in California who died in 1910. He was a seaman/engineer on a ferry boat, later married Margaret- after 1920 census . They had the following children b in California:

Family of Michael (son of John and Mary Walsh) and Anne Gilroy, in San Mateo, California

Assumptions: Walsh women were sisters. Mary was a witness to William, son of Patrick and Nellie.

Family of John Phew -Ballyfruit-possible, only clue is the spelling of the name, location and time frame

John Phew married Ellenor Jennings in 1840 at Shrule Parish, address **Rossdaff** Possibly married twice?

John Phew married Mary Kenny in 1841 at Shrule Parish, address **Ballynalty**. They were on the 1861 census in Liverpool- John was 40 and Mary was 42.

Children Sarah 1842 and Luke 1844 were born in **Shrule** , per census, William 1847 was b in Ireland, but Patrick 1854, Thomas 1858 and Mary 1861 were born in Liverpool.

Michael Phew 1822-1897 Bachelor/laborer **Patrick Flynn** present at death

Andrew Phew DOB unknown after 1822 and 1881, based on newspaper article.

Review of Petty Sessions: John of Ballyfruit was described as a yeoman. In 1881 there are a lot of complaints against John and Mary Phew, I suspect they came back from Liverpool.

Assuming John (1822-1887) is the John on the land records, married to Mary Walsh. He must have fallen on hard times by 1881.

John and Mary appear to be having feuds with the Flynns . John Flynn was a witness to Patrick and Ellen Walsh and James Flynn sponsor for John and Mary Walsh's daughter Catherine. Also feuds with the Murphys and Wm Burke and Percy Bernard.
